- (c) Pre-Sanction Letter of the loaning agency reflecting the loan amount, name of the purchaser and branch address.
- (d) Photocopy of 'Agreement to Sell' duly Notarised.

- (e) Details of the owner / loanee in the Company / Credit Facility (Owner / Director / Proprietor / Guarantor / Other). Documents reflecting details may be forwarded.
- (f) Evaluation Report of the property duly notarized incase loan amount exceeds the Sale value of the property (pl fwd relevant pages of the Sale/ Conveyance Deed).
